MUI continues to strive to resolve issues which affect our Seafarers. Seafarers and their families are free to approach MUI via email or personal visit.

We will continue to focus on return of stranded/ detained Seafarers from overseas, such as Iran, Sri Lanka, UAE, Nigeria.

One of the most significant achievements is the participation of Capt. Tushar Pradhan - General Secretary in the Tripartite IMO-ILO Conference which was held at Geneva, Switzerland this month. Draft Guidelines for Port State and Flag State Authorities on how to deal with seafarer abandonment cases.

Norwegian Agreements for Norwegian and non-Norwegian registered vessels were negotiated and finalised upto 31 December 2024.

ITF National Co-ordinating Committee (NCC) meeting for Indian affiliates of ITF was also held in Mumbai. Interaction included discussion of issues affecting affiliates and future course of action in India, and enhancement of ITF office in New Delhi.

MUI and NUSI held an Interactive Session for companies having Indian Seafarers serving on Japanese owned vessels. Benefits to companies were reviewed alongwith issues concerning seafarers on such vessels.

MUI Womens Wing held a seminar titled Mindful Living For An Enriched Existence.

Resolution of Grievances by MUI

Below are some of the grievances of Officers resolved by MUI. There are a number of cases of similar nature (outstanding wages and sign-off) taken up and resolved.

BALANCE OF WAGES

*We have received email from officer through ITF regarding one of the prestigious company stating the company has not given November 2022 salary to officers. We approached the company and were informed that they had not received payment from their ship owners and needed more time. MUI warned them to pay the salary to avoid action against them. After regular follow up, the Officer received his wages into his account.

*We received email from Master who had not received wages amounting to USD 11,000 after sign off from the vessel. We contacted company via email and telephone. After MUI intervention, outstanding wages were cleared within a week.

*An Officer on offshore supply Indian Flag vessel approached MUI stating company had not paid his BOW INR 5,37,435 and now they were not responding to his emails and not responding to his queries. We called the company and strongly took up this matter, warning them of further action. Company cleared his 2 lakhs within next two days.

DEATH COMPENSATION

Spouse of officer approached MUI stating negligence by the company resulting in demise of her husband. Her husband was taken ashore due to fever and then hospitalized due to COVID-19. However, after treatment for almost two months he expired.

We stood firmly with the family to investigate the matter and strongly supported her by providing legal advice. We have informed company to pay the full amount as per INSA-MUI agreement, including all the expenses pre and post hospitalization.

After pursuing this case by MUI and family finally she got justice and was able to recover death compensation and hospitalization charges from company.

CAPT. TUSHAR PRADHAN - GENERAL SECRETARY ATTENDS IMO-ILO TRIPARTITE CONFERENCE

Capt. Tushar Pradhan - General Secretary is a member of Maritime Safety Committee (MSC) at ITF. He was part of the team which was invited to take part in the 1st ILO-IMO Tripartite Conference held in Geneva between 13 and 15 December, 2022. The conference was to prepare Draft Guidelines for Port State and Flag State Authorities on how to deal with seafarer abandonment cases.



The Maritime Union of India holds an Interactive Session with Indian crew management companies for Japanese owned vessels under the IBF JSU-NUSI-MUI IMMAJ CBA

A meeting between The Maritime Union of India, National Union of Seafarers of India (NUSI) and crew management companies for Japanese owned vessels was held on 23 November, 2022 in Mumbai.

Representatives of companies qualifying for assistance under the Training and Welfare Fund provided by Japan Seamens Union (JSU) and International Mariners Management of Japan (IMMAJ) were present.

MUI and NUSI have been providing financial assistance under this agreement, as Training and Welfare initiative, as well as for higher education of children of seafarers.

The objective of the meeting was elaborated, which is to enhance skills of the seafarers so that they can be on par with the latest developments in shipping. These courses are provided by companies in addition to those that are mandatory under the STCW Convention.

Benefits provided to such companies by both, MUI and NUSI were discussed in detail. Issues of concern directly concerning seafarers were discussed, alongwith those related to various non mandatory courses conducted by companies who qualify to benefit under the above agreement.

Norwegian Collective Bargaining Agreement

Dear Seafarers

There has been an increment in wages and terms and conditions in the Collective Bargaining Agreement Norwegian International Ship Register (NIS) for Indian Officers between The Maritime Union of India and Norwegian Ship Owners' Association (NSA), Norwegian Maritime Officers' Association (NMOA), Norwegian Union of Marine Engineers (NUME), and also Model Agreement (for Non-Norwegian Registered Vessels).



The Maritime Union of India (MUI) took a tough stand during negotiations.

There has been an upward revision in wages and terms and conditions for all ranks as follows :

1. Basic Wage for all ranks has been increased by 2.75% for the period from 01 January 2023 upto 31 December, 2023.
2. Basic Wage has been further increased by 1.75 per cent for the period from 01 January 2024 upto 31 December, 2024.
3. Subsistence Allowance has been increased from USD 8 to USD 9.
4. Death Compensation has been substantially increased from earlier USD 1,08,500 to USD 1,13,400. Additional compensation to each child under the age of eighteen (18) years increased from USD 18,500 to USD 19,300. A maximum payment not exceeding for 3 children increased from USD 55,500 to USD 57,900.
5. Disability Compensation for Senior Officers has been increased from earlier 1,21,500 to USD 1,27,000 and for Junior Officers from USD 1,18,500 to USD 1,23,800.
6. The Maritime Floating Staff Welfare Trust (MFSWT) contribution has been increased from USD 25 to USD 28.
7. During the assignment, Officers are to be given full information of the War Zone inclusion in the ships trading pattern and shall have the right not to proceed to a warlike operations area.

These achievements have been possible because of the active support and interest shown by members of our Union. MUI will continue to strive for betterment of work and wage conditions of seafarers.

ANTI-MARITIME PIRACY

Quelling a menace

In its ongoing winter session, the Indian Parliament (Lok Sabha) took up for consideration the Anti-Maritime Piracy Bill that seeks to provide an effective legal instrument to combat sea piracy not only in Indian territorial waters and the exclusive economic zones of India but also on the high seas. This Bill is in line with the United Nations Convention on the Law of the Sea and was earlier introduced in the Indian Parliament in 2019 before being sent to the Standing Committee for detailed perusal. The United Nations Convention on the Law of the Sea was ratified by India in 1995. The Bill has now been reintroduced by the Indian government, incorporating some amendments as advised by the Standing Committee. The Bill allows Indian authorities to take action against high-seas piracy. The UN Convention on the Law of the Sea will be enacted through this bill. It covers the sea beyond the Exclusive Economic Zone, which is 200 nautical miles off the coast of India.

The External Affairs Minister of India, S Jaishankar, while introducing the Bill in the Indian Parliament, said it will enhance India's maritime security, including those of its trade routes. "The government has tried to suitably incorporate the recommendations of the Standing Committee in the Bill. A total of 14 of the 18 recommendations of the Standing Committee were accepted, adding one of the recommendations which was about having a Standard Operating Procedure for deportation and extradition of pirates by the Ministry of Home Affairs. And, the provision of 'trial in absentia' has been dropped. Also, keeping in mind the observation of the Standing Committee regarding the Supreme Court of India's ruling on avoiding the mandatory death punishment, the provision regarding the death punishment has been amended in the Bill to also include life imprisonment."

Jaishankar said that India does not have a specific law or legal provision in IPC or CRPC on piracy. This bill, along with the amendments, would provide an effective legal instrument

to combat piracy, not only in our territorial waters but in the exclusive economic zones and also on the high seas. He said: "India's security and economic well-being is linked with the sea and maritime security is a prerequisite with more than 90 per cent of our trade with the world taking place through sea routes and more than 80 per cent of our hydrocarbon requirements being seaborne. The security of sea lanes of communication is critical to our national well-being. India is also one of the largest providers of seafarers in the world. The passing of this bill is a logical follow-up of India's maritime initiatives and will also enhance India's maritime security, including that of India's trade routes and the welfare of Indian seafarers in international waters."

Boosting the morale Welcoming the Indian government's initiative to enact an Anti-Maritime Piracy Law, Tushar Pradhan, General Secretary of India's oldest union of merchant navy officers, The Maritime Union of India, said: "Piracy is one of the major factors that affect the growth of the maritime industry world-wide. Yearly, shipping companies across the globe lose billions of dollars because of pirate

attacks. Piracy has affected the maritime industry almost since the oceans have been used for trade. This Bill when it becomes law will bolster the growth of the Indian maritime industry, and also boost the morale of Indian seafarers. Because India currently lacks a local law on marine piracy, prosecuting pirates who are arrested outside of their territorial waters is difficult. The Anti-Piracy Maritime Law of India will address this pressing issue and certainly facilitate the growth of the Indian ship manning industry. It will invariably help our country to increase the global share of Indian seafarers in the longer run."

The menace of maritime piracy, hijacking and violence on the high seas is a major concern amongst ship owners and ship manning companies globally as generally Somali pirates tend to be well armed with automatic weapons, RPGs and have been known to sometimes use skiffs launched from mother vessels, which may be hijacked fishing vessels or dhows.

The ICC International Maritime Bureau's latest global quarterly piracy report details 90 incidents of piracy and armed robbery against ships in the first nine months of 2022. Perpetrators were successful in gaining access to the vessels in 95 per cent of the reported incidents – 85 vessels were boarded, there were four attempted attacks, and one vessel was hijacked. In many of the cases vessels were either at anchor or steaming when boarded, with nearly all the incidents occurring during the hours of darkness. 27 crew members were taken hostage, six assaulted and five threatened.




MUI official participates in Vasai-Virar Marathon

RESCUE OPERATION IN SOUTH CHINA SEA - 303 SRI LANKAN MIGRANTS SAFE

A merchant ship, M.V. Helios Leader, a 60,212 tonne vehicle carrier, with 26 crew on board, under command of Capt. Anil Choudhary was on its way to Singapore from Japan, laden with Japanese and South Korean cars rescued a total of 303 Sri Lankan migrants (264 men, 19 women, 20 children) in South China Sea on 7th November, 2022.

On 7th November, 2022, at 2.50 p.m. crew received an urgent message from MRCC Singapore that a vessel Lady 3, Myanmar flag was sinking off the Vietnamese coast, within Singapore's maritime Search and Rescue region. Their boat had already taken in water and was rolling and pitching in 3 metres high swell. The vessel was believed to be heading to Canada from Sri Lanka. By 3 p.m. Capt. Choudhary altered course and made its way south-west to the vessel. It took 1.5 hours to reach the fishing boat, which was 210 nautical miles off Vung Tau, South of Vietnam.

By 5.40 p.m. the operation to get the 303 passengers off the sinking boat was underway. Capt. Choudhary instructed crew to lower a pilot ladder to the fishing boat for the immigrants who had clambered to the upper deck of Lady 3. "To climb up the ladder you had to be alongside the ship but with the waves, both the vessels were moving up and down. It went haywire", stated Chief Engineer Dinesh Khanna. The crew decided to pull up the passengers one by one by their arms onto the gangway. They secured themselves using safety harnesses and reached over the edge of the vessel

to do this, which was a long and tricky process. Captain Khanna stated that “We had to wait for the right second to pick up each person... We pulled them up with all our effort. They were panicking and tried to climb on all together. We had to tell them not to do so because if somebody fell, we would have to save that person first” and added that, “We said we would not leave this place until we see the last person leave safely”. Captain Choudhary meanwhile made sure that the main engine and side thruster were working to keep both the ships sufficiently close and steady. He instructed his cooks to prepare bread and soup as those rescued would be cold and exhausted. By 7.30 p.m. all passengers were safely on board, and were extremely grateful to their rescuers.

Helios Leader arrived at Vung Tau, Vietnam, 8th November and after clearing immigration, the Sri Lankans began disembarking. The vessel then proceeded to Singapore where the crew were felicitated by MPA Singapore. The vessel was under the management of NYK Ship Management Pvt. Ltd., Mumbai.***

RESCUE OPERATION SAVES TWO MEN AND DOG IN NORTH ATLANTIC

Captain Neeraj Chaudhary, Master of *Silver Muna* rescued two persons, aged 65 and 76 alongwith their dog on 13 December, 2022.

The boat, *Atrivida-II* had sent out a distress message a day before, but the position indicated was more than 500 NM away from his ship. RCC Norfolk requested if vessel can carry out the rescue, to which a positive response was sent to them. On approaching the boat two persons with a dog were visible. However, 5 metres swell with gusty winds in the North Atlantic during winter are common were prevailing. Due to these factors, two maneuvering attempts failed to approach the boat, which was drifting without fuel.

The third attempt was successful, and using line throwing apparatus a rescue line was established. After further maneuvering, the boat was alongside on Portside. However, waves were tossing the 30 feet boat and with the rescue line and pilot ladder broken down, it looked like an impossible task. One of the men on board was simply giving up and believed that they were not going to make it safely. Now, it was decided to use Rescue Harness, however, due to weak condition of the two men, it was decided to use ships crane with strong cargo net and a pellet at centre of the net. The last strong point left on the boat was the iron pole on which the steering wheel was fitted which broke, however, all three were safely rescued unharmed. The vessel was under the management of Fleet Management, Mumbai.***

Merchant Shipping Notice No. 13 of 2022

Subject: Guidelines for the avoidance of false distress alerts- reg.

1. Noting that the false distress alerts activated from VHF, DSC, MF/HF DSC, recognized ship earth station (SES) and EPIRBs may impose a considerable and unnecessary burden on Rescue Co-ordination Centers (RCCs) and on national exchequer by engaging search and rescue (SAR) authorities for carrying out SAR operation, and it could have a potentially serious impact on real distress situations and safety of life at sea. It also has an adverse effect on seafarer's confidence in the GMDSS.
2. In this regards, the Directorate General of Shipping had issued several merchant shipping notices and circulars from time to time to avoid transmission, repetition and relay of false distress alerts in the Global Maritime Distress and Safety System (GMDSS).
3. Recalling the amendments to the Global Maritime Distress and Safety System (GMDSS) as adopted through IMO resolution MSC496(105), and recognizing the need to revise and update the Guidelines for the avoidance of false distress alerts as indicated in the IMO resolution A-814(19), the IMO has issued "Revised Guidelines for the avoidance of False Distress Alerts" through the Resolution MSC-514 (105) dated 28 April 2022. (Copy is attached as Annex-I.)
4. Considering that, the transmission and relay of false distress alerts is a significant problem within the Global Maritime Distress and Safety System (GMDSS), the World Radiocommunication Conference has issued "Operational procedures for cancelling false distress alerts through the Resolution-349 (WRC-19) in November 2019. (Copy is attached as Annex II.)
5. Having realized the serious implications of false distress alerts and with an aim to reduce false alerts, the Directorate General of Shipping bring these revised Guidelines and procedures to the attention of all Ship owners, Ship operators, Ship masters, Seafarers, Training Institutions, Faculties and other maritime institutions.
6. This Merchant Shipping Notice supersedes all previous notices and circulars on the above subject.
7. This is issued with the approval of Director General of Shipping and Additional Secretary to the Govt. of India.

DG Shipping "Seafarers Grievance Redressal Mechanism"

1. Possible means of receipt of "Seafarers Grievances" may be by following means:
 - a. DGS Online grievance portal
 - b. Email
 - c. Twitter
 - d. Hard copy (letter)
 - e. Social media (as Whatsapp etc.)
2. On receipt of grievance by other means than the "Online grievance portal" such as other means as Emails, Tweet, Hard copy (letter) and Social media etc., the concerned seafarer who has raised grievance by other means may be advised by email or call by DG Shipping Official / Shipping Master to raise the grievance through the "DGS Online grievance portal" for quick and easy disposal of case online.

3. Step by step process guide for raising online grievance:

- a) Login to E-Governance system by using User Id and Password provided by DG Shipping for other modules (www.dgshipping.gov.in > E-Governance)
 - b) Go to the link > “Grievance Redressal Mechanism”
 - c) Enter relevant details (* marks details are compulsory)
 - d) Select Company Name
 - e) Select the option “type” of grievance
 - f) Fill up all relevant details and ‘Submit’
 - g) Upon submission of data, system would display “Reference No.” and same application would be sent to the concerned “Shipping Master”
 - h) The concerned “Shipping Master” would examine the matter within two (02) working days and provide necessary solutions
 - i) Grievances would be processed and seafarer would be queried back within two (02) working days with details or closure details would be communicated online
 - j) Seafarer can “view” the status of grievance by clicking “view” status
 - k) If queried back requesting further details, the same may be provided by the seafarer

Below article is presented by Capt. Nagendra Rao, DCIL and is also President of The Maritime Union of India in the above issue.

Capt. Nagendra Rao, Master, DCIL DISASTER MANAGEMENT

It is a sudden misfortune or any unfortunate event. It is an event whose timing is unexpected and whose consequences are seriously destructive. It is a serious disruption of the functioning of a society involving wide spread human, material, economic and environmental losses.

Disaster simply means a mishap, calamity or occurrence in any area arising from natural or manmade causes or by accidents or by negligence resulting in substantial loss of life, destruction to property, damage to environment and it is of such a magnitude as to be beyond the coping capacity of the society of affected area.

TYPES OF DISASTERS:

There are mainly two types of Disasters.

NATURAL DISASTERS: Natural disasters are resulting from natural hazards which are not in our control. These are Cyclones, Cold waves, Cloud bursts, Draughts, Earthquakes, Floods. Heat waves, Hurricanes, Hailstorms, Landslides, Tornadoes, Tsunamis, Thunderstorms, Volcanic Eruptions etc.

MANMADE DISASTERS: These have an element of human intent, negligence or error involving a failure of a manmade system. These are Arson, Biological, Chemical and Gas threats, Cyberattacks, Crime, Civil Disorder, and Oil spills, Terrorism, Wars etc.

DISASTER MANAGEMENT:

Disaster Management means a continuous and integrated process of planning, organizing, coordinating and implementing measures which are necessary for: Evacuation, Rescue and Relief, Rehabilitation and Reconstruction, Assessing magnitude of effects of disaster, Preparedness to deal with disaster, Capacity Building, Reduction of severity of risks of disaster, Prevention of threats of any disaster.

PHASES OF DISASTER MANAGEMENT CYCLE:

RESPONSE / RELIEF: It involves search and rescue of affected people, providing them with food, temporary shelter and immediate medical care. It involves strategies to reduce level of suffering and bringing the affected people from shock and trauma due to loss their loved ones and means of livelihood.

RECOVERY: It refers to decisions and actions taken related to rehabilitation and reconstruction after a disaster with a view to restoring pre-disaster living conditions of affected community. The aim is to develop the areas in such a way that vulnerability and risks to disaster are minimized.

REHABILITATION: This process includes all operations and decisions taken with a view to restore an affected community to its former living conditions, by facilitating necessary adjustments to the changes caused by the disaster.

RECONSTRUCTION: It includes the actions taken to re-establish a community following rehabilitation of affected persons after a disaster. These actions include construction of permanent housing, restoration of water services, communication services, electricity services, transport facilities, medical care etc.

DEVELOPMENT: The main objectives in this phase are to reduce hazards, prevent disasters, and prepare for emergencies.

PREVENTION: Activities aim at avoiding adverse impact of hazards and investing in preventive measures in areas frequently affected by disasters.

NATIONAL INSTITUTE OF DISASTER MANAGEMENT: Established under guidelines of NDMA, to address the dearth of effective disaster management systems and professionals in the country. Its agenda would be the reinvention of disaster management in the country by ensuring disaster prevention, preparedness and facilitating setting up of accountable and participatory systems for disaster response and mitigation, setting up R & D centers, formulating training modules etc.

MITIGATION: Any measures taken to minimize the extent of a disaster. Structural measures are strengthening of buildings, disaster resistant construction and erection of infrastructure. Nonstructural measures are intangible and cannot be quantified. These are generation of awareness, education and training, insurance etc.

PREPAREDNESS: Activities and measures taken in advance to reduce disaster impact by giving effective early warnings, preparation of emergency plans, risk assessment planning, evacuation of people from threatened locations.

INITIATIVES TAKEN BY GOVERNMENT FOR REDUCING RISKS OF DISASTERS:

DISASTER MANAGEMENT ACT 2005: It mandates every Govt.Department to prepare, review, and update Disaster Management Plan.

NATIONAL DISASTER MANAGEMENT AUTHORITY: Constituted in every district level to coordinate with all cities and suburbs under its control.

NATIONAL DISASTER RELIEF FORCE: It was constituted in 2006 under NDMA guidelines by Ministry of Home Affairs. NDRF is headed by Director General with 16 battalions of fully trained force.

NATIONAL DISASTER MANAGEMENT PLAN: It was formulated in November 2019 by National Disaster Management Authority under Ministry of Home Affairs, Government of India. The main features of the NDMP 2019 are:

National Legal Mandates, Prime Minister's 10 point agenda, Social inclusion, Responsibility Framework, Reactive approach to Proactive approach, Regional Approach

Disaster Relief Funds: National Disaster Response Fund, National Disaster Mitigation Fund, State & District Disaster Response Funds, State & District Mitigation Fund.

DOS AND DO NOTS OF MAJOR DISASTERS:

EARTHQUAKES:

If you are inside your home, stay there inside hall, in corners and archways. Avoid staying near windows and doorways. Take cover under a heavy table or solid furniture.

If you are at outside your home, stay well clear of buildings and electric wires/cables.

If you are in a lift, when earthquake happens, press all floors buttons and get out of the lift immediately.

If you are in a vehicle, leave the road clear away from bridges and tall buildings, stay in your vehicle.

If you are in crowded public place, take cover and not to get trampled. Keep away from neon sign boards and heavy display shelves.

Try to remain calm and help others until shaking stops. Anticipate aftershocks also. After earthquake, check your home or office for structural damage and assess for other hazards.

Check yourself and others nearby for any injuries. Administer First Aid quickly. If you are evacuating, take pack of emergency supplies with you. Use torch and wear shoes or chapels as you have to cross broken glasses of windows.

FLOODS:

Move to the safer places with dry food and drinking water on receipt of flood warning.

Valuable household articles and documents to be concealed in polythene bags and to be secured in safe place.

Remove cattle to a highland and store sufficient fodder and drinking water for them

Insure crops and household articles.

Turn off all electric system and equipment's.

Avoid eating infected food and drinking water in open. Boil water before drinking. Keep food covered always.

Conclusion: Capacity building to face any disaster, Preparedness rather than Management, Sustainable Development for faster rehabilitation, Awareness creation to take preventive measures, Extensive training programmes to minimize loss of life and property, save precious lives on Earth. ***


