DECLARATION OF ELECTION

The Maritime Union of India (MUI) will be holding elections to elect President, two Vice-Presidents, General Secretary and Treasurer. In addition to these, an Executive Committee comprising of thirty two members will also be elected, including two reserved seats for Female Officers. This election will be held from amongst the cross section of Indian as well as Foreign shipping companies grouped together. This Election will be held in Special General Body Meeting to be held on 1st August, 2022.

Those who are full members of the MUI but have defaulted in payment upto and including December 2021, prior to this declaration will not be eligible to vote and/or to file his/her nomination.

In addition to above, an officer fulfilling the above mentioned condition should have served at sea for at least 5 years and have at least 5 years of continuous membership of MUI in order to be eligible to file his/her nomination.

Masters, Chief Officers, 2nd Officers, 3rd Officers, Radio Officers, Purser Officers and Medical Officers and Welfare Officers can file their nomination under Deck Section and Chief Engineers, 2nd Engineers, 3rd Engineers, 4th Engineers, Gas Engineers, Electrical Officers, Electronic Officers, Electro Technical Officers can file their nomination under Engine Section.

Ship Owners, Marine and Engineer Superintendents, Ship Managers, Ship Brokers and such other persons directly concerned with administration of shipping company/shipping agents/ recruiting agents, or any other shore Officers are not entitled for the Membership of the MUI and therefore not entitled to file their nomination.

Nomination should clearly indicate the position/ seat for which the Candidate/Member desires to stand.

Members playing an active role of participating in political or non political union/organization in any manner cannot file their nomination.

Please note that MUI is a Trade Union registered under the Trade Union Act, 1926 and a non political organization which believes in serving, upliftment, protecting, welfare, the dignity of Seafarers, predominantly Seafaring Officers, in co-ordination with National and International Seafarer Associations.

An Election Officer is appointed to conduct the present election. Election Officer will declare the Schedule and the procedure of the Election to be held on 1st August 2022 and same would be made available on the official website of MUI.

In order that all sections of the membership should have their representation in Elected Executive Members, the Executive Members' seats are distributed in following categories/section and reservation.

ELECTION SCHEDULE

Nomination

Members desirous of contesting election for the post of Managing Committee member and offering their services to the Managing Committee are requested to send their Nomination Form to Election officer at the address specified in the Nomination form, on or before 15th May 2022.

Withdrawal/ Scrutiny

The Nomination form so received will be scrutinized till 31st May 2022 and the forms completing all the requirements mentioned in present Declaration of Election and those mentioned in Nomination Form will be accepted. The incomplete/ unreadable/illegible/ scribbled nomination forms will be rejected.

The Candidate who are sailing or are outstation and are not able to comply the terms for withdrawal, can inform his / her withdrawal to Election Officer by Candidates E-mail address as disclosed by him/her in the Nomination Form, by sending "Scanned Copy" of "Withdrawal Application" on or before 31st May 2022 (31/05/2022), and posting the "Withdrawal Application" by post.

Voting

The Elections are to be held at Special General Body Meeting to be held on 1st August 2022, (01-08-2022). The Members may vote by remaining present in person, (the member should carry his/her valid MUI Membership Card) in the above referred General Body Meeting between 10.00 am to 5.00 pm (the ballot box will be sealed at 5.00 pm on 01-08-2022) or post their votes to "Election Officer, The Maritime Union of India, 204, 2nd Floor, National Insurance Building, Dr. D. N. Road, Mumbai 400 001, and the same should reach the above mentioned address on or before 5.00 pm, 1st August 2022 (01-08-2022).

Note:

The vote received by post after 5.00 pm, 1st August 2022 (01-08-2022) will be marked rejected and will be discarded.

Counting of Votes

The Counting for votes will start from 2nd August 2022. The Candidates or their authorized representative can remain present at the time of counting for observation purpose.

Results

The results of the Election to be held on 1st August 2022 will be declared as soon as the counting is finished.

Recounting

The Candidate who wishes to Apply for the Recounting can apply till 5.00 pm, of 7th August 2022, by presenting the Application for the same in person, and through email. The Recounting if any will be held on 9th August 2022, and the result of the said recounting will be declared on 11th August 2022.

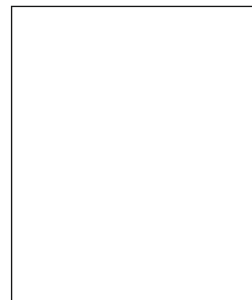
1. Election officer can change the Election Schedule/ dates as per the circumstances/situation and needs for conducting smooth and fair elections.

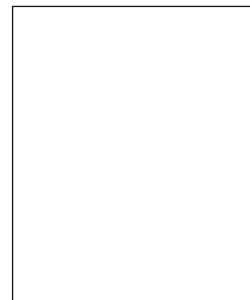
