



Editorial

"Day of the Seafarer", as designated by IMO is celebrated on 25 June every year, to highlight the significance of seafarers worldwide. This programme was celebrated under the aegis of National Maritime Day Celebrations Committee (Central), which is constituted under the Directorate General of Shipping.

The need of the hour is the mental well being of seafarers. We are coming across instances of seafarers appearing to get overwhelmed by life on board. We observe that this is irrespective of the rank and standard of the company of the seafarer. We need to get to the core of the issue, by identifying contributing factors, weaknesses, insufficiencies or lack of appropriate psychological preparedness which life on board demands. Technological demands on board, perceived feeling of isolation, friction with others, so-called modern living, societal pressures, while on shore may create a deadly combination which tend to build up frustrations and may lead one to resort to take rash and irreversible decision to harm oneself, including taking ones one life.

It is to be noted that cases of abandonment of seafarers is on the rise. Seafarers do not get their wages for months and at the same time, they are stuck on vessels, with low provisions, bunkers, no emails and contact with their families. MUI takes such cases very seriously.

Seafarers are vulnerable from the point of view of being taken to task to an unjustifiable extent. They may have flouted certain rules and got detained. But to treat them as criminals is just not acceptable. This is where MUI plays an important role and ensures fairness.

Seafarers should demand to avail legal advice or consult Union, before issuing any statement whenever they are detained or questioned regarding any alleged offence/incident.

In order to enable us to assist better, Officers must ensure that their membership is kept updated. This will ensure that we can take up their matter in the court of law if need be on a stronger footing. Your Union will always be there to guide you with regard to taxation, legal and other aspects related to your career. In case you have any queries you can just drop us an email and we will follow up.

Instances of detention of ships Indonesian navy, allegedly for having dropped anchor in Indonesian waters have been on the rise. Around seventy Indian seafarers are currently under detention at present. MUI has putting in its efforts with relevant authorities. However, one has tounderstand that the task to secure release of seafarers is bound to be difficult. as it involves government and defence sector of Indonesia. Assistance from Indian government is also of paramount importance. In this direction, MUI intends to put in more efforts not only in this particular case, but also in other countries at present and in the coming days, as and when the need arises.

MUI Womens Wing continues to work towards empowerment and spouses of seafarers are welcome to avail its membership.

MUI assures all that we will continue to work ceaselessly to ensure justice for our seafarers. * * *

The love for our country not only exists in civilians, But also in the sacrificing youth guarding its borders by the millions.


The beauty and reflection of innovation stands in everyone's eyes,

STANDARD OPERATING PROCEDURE [SOP] FOR INDIAN SAILING VESSELS OPERATING ON INTERNATIONAL VOYAGES.

The Director General of Shipping, vide DGS order No. 10 of 2018 dated 22.11.18, has considered that it would be appropriate to frame separate rules for vessels engaged in coastal trade, in the interest of public health, till such time that separate rules are framed.

The Director General of Shipping has issued "Standard Operating Procedure" (SoP) for Indian Sailing Vessels operating on international voyages vide DGS Order No. 11 of 2018 dated 07.12.18. The SoP deals with procedures and actions required by all stakeholders in case of piracy/ hijacking incidents, safety measures to avoid piracy incidents, requirements for carrying various communication equipments etc. The SoP has been prepared with an aim to formulate a comprehensive security/ operating plan for safe operation of Indian sailing vessels in international voyages. This SoP is mandatory to be complied with by all sailing vessels registered under the MS Act, 1958 and operating on international voyages. Non-compliance of the SoP will result in severe penal action as specified under Part XVI 'Penalties and Procedure' of the said Act. –-DGS quarterly newspaper

Capt. Belal Ahmed takes over as IMEC Chairman



The International Maritime Employers' Council's (IMEC) Annual General Meeting was held in Southampton, UK on the 10th April, where the Chairmanship was handed over from Capt.

Rajesh Tandon, to Capt. Belal Ahmed.

When Capt. Tandon originally took over the role of Chairman in 2014, he knew the organisation would be facing a tough negotiation period. The International Bargaining Forum (IBF) had experienced a history of giving seafarer wages increases, despite the state of the shipping markets and the recent negotiations in Indonesia had been no different. However with the shipping market cycle heading towards the lowest point of the depression, the employers' side of the IBF were going to have to face hard negotiations.

It was perhaps unsurprising that when the IBF met for the next round of negotiations in 2017, the social parties quickly met deadlock. Strong leadership and the maturity of the negotiation process allowed the employers' and seafarers to come back to the table the following year and agree on a 4 year deal.

Capt. Ahmed's Chairmanship represents a new chapter in IMEC, as he represents the Ship owning group within IMEC. IMEC represents employers' across shipowners, ship managers and crew managers, but it has been over 10 years since the Chairman came from a shipowning member. Capt. Belal Ahmed takes over the organisation at a time of substantial growth. Despite the economic downturn, IMEC's membership has grown by 20% in the past 5 years and has recently announced the largest intake of it' cadetship programme in the Philippines, with 260 cadets being recruited in 2019.

In the evening of the AGM, IMEC's members and social partners inaugurated IMEC's new office in Solent Business Park in Hampshire. Last year the organisation relocated from rented accommodation in London, to a larger company owned premises in Hampshire.

Subject: Indian nationals holding restricted Indian Continuous Discharge Certiflcate (CDC) in the.category of Higher National Diploma (HND) recognized by foreign Maritime Administration and GMDSS certificate holders - reg

Whereas, the Merchant Shipping (Continuous Discharge Certificate) Rules, 2017 were notified on 14.07.2017 and is being implemented from 10.01.2018. Sub-Section (3) of Rule 4 of the said Rules superseded the Merchant Shipping (Continuous Discharge Certificate) Rules, 2001.

- 2. And whereas, under the CDC Rules, 2001 the Directorate had issued Merchant Shipping Notice No. 8 of 2011, Merchant Shipping Notice No. 29 of 201 3 & DGS Order No. 11 of 2014 regarding restriction on CDC of GMDSS (GOC) certificate holders; and Merchant Shipping Notice No. 10 of 2013, read with Merchant Shipping Notice No. 4 of 2014 regarding restriction on CDC of Higher National Diploma (HND).
- 3. And whereas, the extant CDC Rules, 2017 do not provide any rank or category in the CDC or limitation on duration of the validity of CDC.
- 4. Now therefore, the restriction made vide above said Merchant Shipping Notices and DGS Order, as far as said ranks and categories are concerned, has become infructuous and thereby revoked.
- 5. Seafarers holding such CDCs issued under Merchant Shipping (CDC) Rules, 2001, may approach the Shipping Master concerned for removal of restrictions mentioned in their CDCs.

Merchant Shipping Notice No. 04 of 2019

Sub.: Listing in Mobile Station License of non – GMDSS equipment fitted on board Indian flag Ships – reg.

- 1. The Ministry of Communications (Department of Telecommunications) vide G.S.R. 1211(E) dated 14.12.2018, has notified the 'Flight and Maritime Connectivity, Rules 2018'. The said Rules enable voice and data services to be provided on board Indian vessels, if desired by the ship owner.
- 2. Indian shipping companies have sought clarifications whether details of equipment installed for providing voice and data services such as VSAT equipment etc., installed on Indian vessels needs to be also listed in the 'Mobile Station License' issued to the vessel.
- 3. In this context, it is clarified that during a meeting held on 04.01.2019 chaired by Secretary (Telecommunication) at Sanchar Bhawan, Ministry of Communications (MoC), New Delhi, the Wireless Advisor to the Government of India had stated that

currently only Global Maritime Distress Safety System (GMDSS) equipments fitted onboard Indian vessels are listed in the 'Mobile Station License' issued to Indian vessels. If any change is made to this requirement, the same would be communicated to all concerned by a suitable order / instruction by the Ministry of Communication. In view of the same, it is clarified that till such time such order / instruction is issued by the Ministry of Communications, there is no requirement for insisting on listing of non-GMDSS equipment including VSAT equipment in the Mobile Station License issued to the vessel.

- Whereas "Indian National Database of Seafarers" (INDoS) number is a unique number issued to a seafarer and this number is required by every aspiring seafarer desiring to undertake any pre-sea course in any Maritime Training Institute (MTI) approved by the Directorate.
- Whereas an aspiring seafarer should readily have the information of the various maritime courses and the Maritime Training Institutes (MTI) approved by the Directorate (DGS) for conducting such maritime courses.
- Whereas the current procedure for issuance of INDoS requires submission of substantial documents and payment of fees by demand draft to the INDoS cell.
- 4. Whereas there have been many cases where a seafarer has applied for multiple INDoS number which created lot of confusion and improper data.
- 5. Noting that a large number of corrections were required pertaining to the personal details of an aspiring seafarer like name' date of birth, passport number, father's name, etc. Also noting that all these corrections caused inconvenience to the seafarer and the MTI while generating certificates for the conducted courses.
- Noting that several corrections essentially require the passport details for verification. Additionally, the name of seafarer in all the certificates require to be as mentioned in the passport.
- 7. Noting also that INDoS number is required for a seafarer and has no significance if the aspiring seafarer does not join maritime courses.
- 8. Taking cognizance of the above, the Directorate has developed the following simplified online procedure for registration of candidate for admission in Maritime Training Institute and issuance of INDoS number to facilitate the seafarers and the MTI.
- Instructions and Procedures for registration of candidate and issuance of INDoS number to the Candidate -
- 9.1.Instructions to be followed by Candidate for application for registration for admission in Maritime Training Institute:
 - 1. The candidate must have a valid passport.

- 2. The candidate must have tenth class pass marksheet unless exempted by DGS Circular.
- 3. No fee is charged for registration for admission in Maritime Training Institute.
- 4. Upon successful registration for admission, the candidate shall receive a system generated "Reference number". The candidate shall note this "Reference number" for future correspondence.
- 5. The "Reference number" issued to a candidate shall be valid for a period of three months from the date of issue of "Reference number". The candidate must seek admission in a Maritime Training Institute within these three months. If the candidate fails to seek admission in Maritime Training Institute within the three months period, the candidate may register again and a new reference number shall be generated for the candidate.
- Prior to admission, the candidate is required to have "Indian National Database of Seafarers" (INDoS) number. The Maritime Training Institute shall apply for "Indian National database of Seafarers" (INDoS) number of the candidate.
- The candidate shall be physically present with all original documents in the Maritime Training Institute during verification for generating the INDoS number of the candidate.
- 8. The candidate shall be charged a total fee (including GST) of Rs. 1416/- (Rs.1200/-+18% GST) for Indian nationals and Rs. 3540/-(Rs.3000/-+18% GSI for foreign nationals for generating the INDoS number.
- The Maritime Training Institute shall not charge any fee from the candidate for generating the INDoS number.
- 9.2. Procedure for Online registration of a candidate for admission in a Maritime Training Institute (MTI):
- Step 1: The candidate shall go to DGS website www.dgshippine.eov.in
- Step 2: Click on tab '(Maritime Training" and in the dropdown list click on "Admission in Maritime Training Institute".

1. Introduction and Requirement:

- (i) RECALLING that the Directorate has prescribed the syllabus and mandatory requirements for the conduct of Extra First Class Engineer Certificate of Competency vide the DGS EAC branch circular 125 of 2014.
- (ii) NOTING that one such requirement is the successful completion of the course and examination within a maximum period of five years from the date of first enrollment for the course, failing which, the candidate has to undergo the complete course and examination all over again.
- (iii) NOTING ALSO that the Extra First Class is an optional certificate with the objective of enhancing the knowledge of existing Marine Engineers with MEO Class I certificate of competency with the new tools for their professional development and accordingly the new syllabus was drawn out and introduced in the year 2014.
- (iv) CONSIDERING that many seafarers and other candidates who have enrolled in this course leading to Extra First class certification in the year 2014 have expressed that they may not be in a position to complete the examination within the prescribed five year period from the date of enrolling the course and as such requested for grant of additional time period for competing the course.

- (v)REALIZING that many candidates who have enrolled in this course have their official duties, few sail onboard merchant ships and some attend to ships as superintendents and as such these candidates could not effectively utilize the time to complete within stipulated time frame of five years and considering that this year (2019) being the completion of first five year period after the introduction of new syllabus and pattern of examination for extra first class certificate of competency in the year 2014, it has been decided to grant one time relaxation to the prescribed period of five years for completion of the course and examination from the date of enrollment.
- (vi) IN CONSIDERATION OF ALL ABOVE one time relaxation in the prescribed period is granted to complete the extra first class examination to all such candidates who have enrolled for the course from 2014 to 2019 to complete within a maximum period of 7 years. Thereafter no relaxation in the five year period will be considered to all such candidates who will enroll for the course from 2020 onwards.

This circular is issued with the approval of the competent authority and comes into effect from the date of issuance.

Recognizing that there has been a significant improvement in CoC examination processes of the DGS e-governance system and that the same is effectively contributing in reducing the time taken for service delivery, the Directorate is further determined to expedite and facilitate the process of assessment and booking of examination seats for all the grades of CoC examination.
- 2. Noting that the Directorate has issued the STCW Training Circular No. 01 of 2011 (F.No. TR/CIR/6(3)/2011) dated 10.02.2011 specifying the pre-sea training and certification requirements for Electro-Technical Officers (under Regulation III/6 of the STCW Convention) and STCW Training Circular No.08 of 2011 (F.No.TR /CIR/6(5)/2011 dated 06.09.2011 specifying the requirement of a bridging course for the Existing Electrical officers (under Regulation III/6 of the STCW Convention).
- 3. Noting also that the Directorate has issued the Instruction to Examiners circular No. 131 of 2015 (F.No. ENG/EXAM-17 (9)/99-III) dated 31.12.2015 specifying the Training and examination requirements for existing Electrical Officers for certification under the STCW Convention as Electro Technical Officers.
- 4. Considering that the system requirements for online submission of application through the DGS egovernance module are in place and have been successfully tried out, the Directorate extends the

- assessment and seat booking, CoC issuance online module to the ETO examination as well.
- 5. Therefore, all candidates applying ETO examination for June, 2019 exams, onwards, are required to apply through online system of DGS egovernance system. Fresh candidates can book online, for assessment and seat booking and the existing candidates who are already in pipeline by the virtue of manual booking, their details and all previous data should be entered in the ETO online module so that all candidates register in the online system for ETO exams from June 2019.
- 6. The Procedure for applying for the ETO examination for the fresh candidates for assessment and seat booking and also the procedure for the existing candidates examination is enumerated in Annexure-1.
- 7. The ETO examinations assessment seat booking and CoC issuance to be totally online through the e-governance system from June 2019 exam onwards and no more manual bookings need to be continued.



Crew Branch Circular No. 03 of 2019

Sub: New procedure for uploading seafarers engagement and discharge data [Article of Agreement and Form-I, RPSL] - reg.

Whereas, vide Crew Branch Circular No. 1 of 2019 [F.No. CR/RPS/5/2018] dated 31.01.2019, the draft new procedure for submission of seafarer's engagement and discharge data [Article of Agreement and Form - I of RPSL] was circulated for its commencement w.e.f. 01.03.2019 and for obtaining comments if any, thereon from the end-users by 10.02.2019.

- 2. And whereas, after getting the feedback from the stakeholders, the last date of updating pending data by 15.03.2019 by them was considered by the competent authority.
- 3. Therefore, the said new procedure for submission of seafarers' data in respect of their engagement and discharge has been implemented and the same is functional w.e.f 16.03.2019 as per the following formulation:
- (1) The "Date of Sign On Shore'/'Date of Commencement of Contract" shall be entered within 15 days from the date of contract signed.
- (2) The "Date of Sign On Ship" shall be entered within 30 days from "Date of Sign On Shore'/'Date of Commencement of Contract".
- (3) The "Date of Sign Off Ship" shall be entered within 15 days from the date seafarer signs off from the ship.
- (4) The "Date of Sign Off Shore"/"Date of Completion of Contract" shall be entered within

- 15 days from the date of the signed off shore.
- (5) The system will not allow to submit any data if the details are not submitted in the stipulated time frame.
- (6) The system will not allow to submit data of seafarers more than the number of seafarers covered under bank guarantee at any given point of time.
- 4. In the event of default of the said provisions of new procedure, the shipowner/RPSL shall be debarred from using the said system for a period of one month.
- 5. In the event if it is reported by the seafarers concerned that their data has not been uploaded by the company/RPSL then the company/RPSL shall be debarred from using the system for a period of 3 months.
- 6. Repeated defaulters shall be debarred from using the DGS e-system besides strict action against them under the provision under Section 436 of M.S. Act, 1958 and M.S. (R&PS) Rules 2016.
- 7. This issues with the approval of Director General of Shipping and Additional Secretary to the Government of India.

Subject: RMI Guidance to Vessels Operating in or near the Persian Gulf, Strait of Hormuz, And Gulf of Oman

In view of recent reports indicating heightened Iranian readiness to conduct offensive operations against U.S. forces and interest, the Republic of the Marshall Islands (RMI) Maritime Administrator has issued the Ship Security Advisory No.05-19 (copy attached) which supplements information and navigation warnings routinely provided by other sources concerning vessels operating in or near the Persian Gulf, Strait of Hormuz, and Gulf of Oman.

Administration has provided following guidance for RMI flagged vessels operating in these areas:

- 1. In the possibility that a vessel is hailed by non-coalition naval forces, vessels navigating these waters are required to provide vessel name, flag State, and affirm that they are exercising navigation rights in accordance with international law, as reflected in the United Nations Convention on the Law of the Sea (UNCLOS).
- 2. If non coalition naval forces seek to board vessel navigating these waters, the ship's Master is required to, if the safety of the ship and crew would not be compromised, decline permission to board by noting that the vessel is exercising navigation rights in accordance with international law.
- 3. If non-coalition naval forces attempt to board, the crew should immediately contact the U.S. Navy's Fifth Fleet Battle Watch. The crew should not forcibly resist the boarding party. Refraining from forcible resistance in no way indicates consent or agreement that such a boarding is consistent with international law.

- 4. All vessels are required to be aware that coalition naval forces may conduct maritime awareness calls, queries, and approaches to ensure the safety of vessels transiting the Persian Gulf, Strait of Hormuz, and Gulf of Oman. Vessels approaching coalition naval forces are advised to maintain radio contact on Very High Frequency (VHF) Channel 16.
- 5. In addition, vessels are also advised to establish contact with the United Kingdom Maritime Trade Office (UKMTO). UKMTO advisories, warnings, and contact info are available at http://www.ukmto.org
 - Administration has advised to report any incidents immediately to coalition naval vessels on VHF Channel 16, the 5th Fleet Battle Watch via phone at + 973-1785-3879, and email details to: BWC@ME.NAVY.MIL
 - RMI flagged commercial vessels bound for the Strait of Hormuz in either direction are encouraged to contact the U.S. Navy 5th Fleet Naval Cooperation and Guidance for Shipping Watch at least two days prior to transit at: NCAGS_BW@ME.NAVY.MIL or +973-3904-9583.
 - All suspicious activities and events must be reported to the RMI Maritime Administrator at dutyofficer@register-iri.com and shipsecurity@register-iri.com.
 - Ship owners/ operators and masters are advised to take note of above and requested to forward this Ship Security Advisory (SSA) to their ships.

SHIP SANITATION CONTROL CERTIFICATE/ SHIP SANITATION CONTROL EXEMPTION CERTIFICATE

All vessels are required to be in possession of Ship Sanitation Control Certificate or Ship Sanitation Control Exemption Certificate, issued by the Port Health Officer. However, when the vessel calls at ports where Port Health Officer is not stationed or is not available, DGS, vide DGS order No. 10 of 2018 dated 22.11.18, has considered and relaxed that issuance of a 'Statement of Compliance' (in lieu of a Ship Sanitation Control Certificate or Ship Sanitation Control Exemption Certificate) in the prescribed format may be issued by a medical examiner authorized by the Directorate General of Shipping. —D GS quarterly newspaper—DGS quarterly newspaper—

NT Wing Piracy Circular No. 03 of 2019

Sub.: Maritime Security Advisory 03 of 2019: 'Restriction in engaging Indian seafarers on vessels trading solely in Gulf of Guinea' - reg.

For the attention of Ship Owners, Ship Managers, Shipping Agents, RPSL Agents, Ship Masters, Seafarers, Charterers, Ship Builders, Ship Breakers Association, Classification Societies recognized by Directorate General of Shipping, Non-exclusive Survey companies, Insurance Companies, Coastal State including Administrations of Union territories/Islands and Maritime Boards.

- 1.Piracy/armed robbery attacks in the Gulf of Guinea are becoming more violent with a greater tendency to attack, hijack and rob vessels as well as. kidnap crew, in the waters of Gulf of Guinea. These attacks having also been reported up-to 170 nautical miles from the coast. In many of these incidents in the Gulf of Guinea, pirates have hijacked the vessel for several days, ransacked the vessel and stolen part cargo (usually gas oil). Additionally, in these past attacks, ship's crewmembers have also been injured, kidnapped and in certain occasions taken ashore for ransom.
- 2.As per IMO promulgated reports of attempted attacks by pirates and armed robbers via the Global Integrated Shipping Information System (GISIS), the sum total of the number of incidents of piracy and armed robbery in West Africa, as reported to IMO in the 10-year period from 1 January 2009 to 31 December 2018, was 555. Additionally, the number of acts of

- piracy and armed robbery against ships in West Africa as per GISIS covering the period 1 January to 31 December 2018 was 81 and reflected a comparable increase from 49 incidents reported in 2017. During these ten years, 2018 also shows the highest in the number of episodes, with 3 ships reported hijacked and 86 crew held hostage in that year.
- 3.Additionally, there appears to be an increasing trend in the number of incidents taking place inside the various Coastal States jurisdiction in the Gulf of Guinea. From two recent incidents, it has come to the attention of this Directorate that foreign nationals especially Indian seafarers are being selectively targeted during such piracy/armed robbery incidents.
- 4.Accordingly, all RPSL agents are instructed to not engage any Indian seafarers on coastal vessels trading solely within the ports in Gulf of Guinea (i.e. Benin, Ghana, Togo, Nigeria, Cameroon, Gabon and Equatorial Guinea). All concerned stakeholders are also advised to take note of the information provided in this advisory and act accordingly.
- 5. This is issued with the approval of the Director General of Shipping.

DGS Show Cause Notice to Maritime Training Institute

The Directorate received information that the MTI "Pragati Marine College", Office No.503, New Bombay Co-operative Commercial Complex, Plot No.43, Sector - 11, CBD Belapur, Navi Mumbai - 400614, is uploading batch details of candidates for "Basic Safety Training" course and issuing certificates to the candidates without imparting the required training. The data submitted by the MTI for the subject course was immediately checked and it was noticed that the MTI had uploaded batch details for 22 candidates for the subject course starting from 13 / 05 I 2019. In order to carry out physical verification, the Directorate directed MMD, Mumbai to conduct a surprise inspection on 14 .05.2019.

- 2. As directed, the inspecting team conducted a surprise inspection of the Pragati Marine College at Belapur on 14.05.2019 from 1030 hrs till 1800 hrs.
- 3. The inspection report of the surprise inspection carried out at the MTI of 'Pragati Marine College", Belapur, Mumbai was reviewed at the Directorate along with the objective evidence submitted. A brief of the various deficiencies noted is enclosed herewith as Annexure.
- 4. The deficiencies were found to be of serious

nature and shall be treated as major deficiencies. Some of the major deficiencies were related to:

- a) Issuance of course certificates to candidates without imparting training.
- b) Uploading batch details of candidates who did not attend the courses.
- c) Principal and Course In-Charge signing certificates of candidates without verification of the candidate (No photograph and signature of the candidate).

Also, signing certificates for the candidates for whom there is no objective evidence of attending the course.

- d) Video recordings for practical training, biometric attendance and other records as required by DGS Training Circulars and Guidelines not available.
- e) Processing issuance of INDoS number without physical verification of documents.
- f) Improper issuance of fee receipts.
- g) The MTI is not certified as per ISO standards as required.
- h) Substandard infrastructure and use of institute premises by other company.

As a seafarer's wife, I want to touch upon a few things of the past; some forgotten, some remembered fondly incidents and memories that every seafarer and his lady can identify with. My source of information has mostly been my husband. He has shared a lot about his work and social life, as I'd express interest in the stories of the sea and the sailors. I have a particular liking for the breed. I always referred to his team onboard as the 'brigade'. I shall cover a few good old memories here, as it is rightly said that old is gold. This bouquet of memories is particularly shared for the benefit and understanding of the young seafarers and their better halves. A woman who understands her husband's profession understands him even better and a seafarer's wife contributes hugely to his success.

I found the only thing connecting the past, present and future times for the sailors, is the good old **Biryani!** So much has been spoken about this Sunday delicacy. No sailor needs any intro to 'The Chicken Biryani'. Some of them fast the previous day so that they can make the most of their date with the Biryani. Yesterday I received the Sign off calendar from my husband and the unit of calculation was the Biryani. I know he wanted me to have a nice laugh and count the biryanis too. Unfortunately no matter how much I miss him I can't have biryani every Sunday!

People carry a lot of misconceptions about sailors or their profession. I remember when I told my colleagues and friends about me marrying one. They instantly came up with the most common unwarranted comment, "A sailor has a wife at every port." I would laugh it off as I understood what happened onboard and outside. Coming to my own experience, the fiancé didn't even know how to ask me out forget taking me on a date. If he happened to be on the side of town where my office was he would pick me and drop me home, as if I was a highly perishable commodity that needed to be deposited home in the nick of time. This man can't have a distant girlfriend, forget a wife.

Let's look at some other glorious things from the past, take it with a pinch of salt, all in good humour.

The haircut Saga

While onboard it became the moral responsibility of every cadet/ young officer to display his skills as a

hair dresser. No matter whether he could handle a pair of scissors or not, he had to do a good job with it; otherwise he'd be entrusted with other jobs too!

Mending Clothes

Women, read it as middle aged ladies; would visit ships at the ports and do the mending job for clothes. A stitch here and tuck there or fixing that loose button. It was one opportunity to see the fairer sex around. No complaints but the ones who came giving their clothes would be dressed well and smelling a lot better than they would on other days.

Mobile Phones with calling cards

Talking about days when there weren't hand phones in use. Sat phones were expensive, so the sailors looked forward to the girls who'd visit ship with mobile phones and calling cards. The crew onboard could call home from their cabins, which was a luxury. Even if one didn't intend calling home, the pretty girl who came with the phone was reason enough to make that one call. Need I add that the men dressed even better than they would while giving their clothes for mending? Looking, feeling and smelling good, all in one; there was a certain charm to it. A lot of made up stories would be shared among the group and they'd remain the top talk till the next such visit onboard, making the adage - 'Empty vessels make a lot of noise' true. All jazz and hardly any truth in it.

Ship chandlers

Ship chandlers, along with their lady colleagues would bring not only provisions but a lot of happiness for the crew onboard. Any opportunity to see a beautiful lady was never missed.

The Master

The captain or the master was commanding the vessel in the real sense. He only had to order and all was done. He had a radio officer with him and also a purser. His job was planning the operations; execution was the duty of the Chief Officer and his team. The top two, Captain and the Chief Engineer were the top guys in the real sense, mostly sporting the royal beard as well.

Shore leave

The crew looked forward to the shore leave since in those days they were quite common. All were happy to go out and spend some money. This was pre ISPS and 9/11. With the implementation of

ISPS, shore leaves have been restricted to the extent that some are stopped altogether.

There was a certain charm that the shipping industry carried which has changed to quite an extent. There was luxury which is commonplace now. Captain's job profile has changed too. Not just a commander any more, he has to double up for a lot of others when there is a need. However, today this applies to all jobs. Ships have connectivity and everyone uses mobile phones. One is in touch with the outside world virtually and with family and friends over video calling. Only

shows the industry has changed for good and technology has made life easier. But good old days do bring a smile on our faces as the new generation of seafarers will never connect with some of the things of the past. Change is inevitable and the obvious way forward.

TAXATION AND YOU Jayant Menezes FCA - Chartered Accountant

The last budget on 1st February, 2018 had made some changes. A few are explained below:

I Section 80D Mediclaim

- (i) For senior citizen this deduction is available up to Rs.50,000/-
- (ii) For others maximum deduction allowed is Rs.25,000/-

II. Section 112A: Sale Consideration of Shares/Units is now taxable.

Earlier under section 10(38) tax on long term capital gains on sale of shares and redemption of equity mutual funds was nil. With effect from assessment year 2019 – 2020, the cut off date is 31/01/2018. So the higher cost of acquisition of shares or units of mutual fund is to be taken as purchase consideration. You are entitled to get an exemption upto Rs.1,00,000/- from the long term capital gains. This is explained below:

How to arrive at long term capital gains from sale of shares and equity mutual funds:

- 1 find the sale value of shares
- 2. find out the cost of acquisition of shares / units
- 3. find the value as on 31/01/2018
- 4. The higher of (2) and (3) will be taken as purchase consideration for each sale
- 5. Difference between Sale Value and (4) will be Long Term Capital Gains
- 6. You get an exemption of Rs. 1,00,000/-

III.In the new ITR forms for AY 2019-2020.

- 1. Nature of jurisdiction is required
- 2. Date of departure and date of arrival in India is required to calculate the duration of stay in India for the Previous Year 2018-2019. This exercise will also have to be calculated for and four earlier Previous Years to find out the days in India.


